### **Understanding the Militia Violent Threat**

The modern militia movement that arose in the 1990s was primarily fueled by anti-government sentiment, manifesting in armed standoffs against the federal government in places like Ruby Ridge, Idaho, and Waco, Texas. More recently, unlawful private militias increasingly have engaged in more public displays of force—storming statehouses in opposition to pandemic-related restrictions, deploying to racial justice demonstrations to “protect” private property and attacking the U.S. Capitol to prevent the certification of the Electoral College Vote. They have joined forces in their messaging and means with other extremist individuals and groups, including white supremacists and conspiracy theorists, while seeking to present themselves as “patriots” whose purpose is to uphold constitutional rights. The UC Berkeley Human Rights Center Investigations Lab has worked with journalists from Reuters and the Associated Press as well as UN fact finders to find, verify, analyze and present open source information uploaded to social media involving violence against the Rohingya in Myanmar. This Pulitzer-prize-winning work most recently involved the HRC Investigations Lab working with the Associated Press to scour thousands of social media posts to find evidence of specific crimes, which was then shared with both reporters and UN fact-finders.

This panel discusses how students, open source investigators, journalists, activists and lawyers are collaborating in new ways to use digital information to uncover hate speech and international crimes in Myanmar and around the world. This panel also addresses whether there are more effective ways for reporters and pro bono counsel to work together while preserving appropriate confidentiality.

In Auschwitz, among the last words Survivor George Brent's father spoke to him were, "Don't Forget Me." ### A Promise Kept

Fritzie Fritzshall survived for months inside one of the Nazi's most notorious camps. Working as a slave laborer in a nearby factory, Fritzie was imprisoned with 599 other women. Each night the women would share with Fritzie a precious crumb of their bread in the hope that the youngest among them might survive to tell the world what had happened to them. In turn, Fritzie promised that if she survived, she would tell their story. Premiered at the 2021 SxSW Film Festival.

### **Interactive Survivor Experience Utilizing Dimensions in Testimony**

Long after the last Holocaust Survivor has passed on, their stories will survive, thanks to the groundbreaking Dimensions in Testimony, developed by USC Shoah Foundation in association with the Illinois Holocaust Museum & Education Center. Dimensions in Testimony enables Survivors to tell their deeply moving personal stories and respond to questions from the audience, inviting visitors to a personalized 'conversation.' This state-of-the-art technology incorporates interview content recorded with advanced filming techniques, natural language processing, and specialized display technologies to deliver a learning environment where a Survivor answers questions and responds to visitors as if he or she were in the room. This impactful experience builds the capacity for empathy – necessary for standing up against injustice.

### **Preview of Not In Our Town Film on Pittsburgh's Response to Hate and Anti-Semitism**

Filmmaker Patrice O'Neill will be joined by Journalist/Editor Robert Rosenthal to share scenes from the documentary and discuss urgent issues and solutions emerging from Pittsburgh's response to hate. A conversation with the audience will follow the presentation.

[Repairing the World: Stories from the Tree of Life](#) documents the Pittsburgh community's response to hate and anti-Semitism in the aftermath of the assault on three congregations at the Tree of Life synagogue. The lives of eleven people were taken on October 27, 2018, in the deadliest anti-Semitic attack in U.S. history. As the Jewish community faces tremendous grief and the stunning resurgence of an age-old threat, they meet fear with courage and join with their neighbors to confront hate and strengthen the connections they had been building for years. Against the backdrop of a tumultuous period in the country, a traumatized community works to heal as they experience the impact of anti-Semitism, racism, hate speech and gun violence. Through the voices of survivors, family members, diverse Pittsburgh residents and leaders, the film shows the powerful display of unity in a moment of crisis, the resilience of a vibrant city, and a community working together to understand what "Stronger than Hate" means in daily life.
