PRIVACY POLICY AND WEBSITE TERMS OF USE

Purpose and Principles

The purpose of this Privacy Policy and Website Terms of Use ("Policy") is to help you understand the personal information that the Eradicate Hate Global Summit ("EHGS") collects, and how it uses and protects that information.

We value the privacy of others' personal information and will undertake reasonable measures to protect and preserve its privacy and confidentiality. We will not ask for, collect, or preserve personal information unless we need it for purposes of legal compliance, providing services to you, or other business purposes, such as fundraising and communications. We will not collect your personal information unless you agree to provide it knowingly and voluntarily.

We will not share others' personal information with anyone without prior approval unless required by law, to protect our rights, or to provide services or process transactions. Our website and other databases will only be used for lawful purposes.

Your Agreement to this Policy

By visiting the EHGS website, registering to attend or speak at an EHGS conference or program, or requesting EHGS information or services, you agree to the terms of this Policy. You also agree that this Policy does not restrict our use or dissemination of publicly available information concerning you.

Please note that other policies govern our use or dissemination of photos and images of you.

Definitions

"Personal information" means information that identifies your personal email, your residence, your residential and cell phone numbers, or your personal credit card numbers, or that pertains to financial, health, or other confidential, private information concerning you or your family. It does not include publicly available information, such as business address, business contact information, or photos/images.

"Share" means to sell, rent, lease, send, transfer, or otherwise provide in any way or format.

Personal Information Collection.

We may collect personal information that you voluntarily disclose through media, including our website (including donations and requests for information), email, mail, telephone, or fax. We

also collect personal information required for you to register and pay, if necessary, to attend our conferences and programs, for us to engage in other business transactions with you, or to provide services or information requested by you.

Use of Personal Information.

We collect and preserve only the minimal personal information needed to enhance our services and communications, to process payments, donations, registrations, and other transactions, to provide the requested services or information, or to comply with legal requirements. We may use personal information to contact you about EHGS activities, fundraising, or as otherwise disclosed to you at the point of collection.

Personal information may be shared as necessary with our staff, contractors, service providers, vendors, or affiliated entities, such as a bank, an event planning or registration company, or a credit card processing company, to complete a transaction with you or to provide services or information requested by you. We also may preserve that information for our later business use; however, we will not share any of your personal information with anyone else without your prior approval.

We will delete and not store any credit card or other payment information after the conference or other business transaction has concluded and the payment has been processed.

You may request us to report to you the personal information that we have stored and to delete your personal information after it is no longer needed for you to attend a conference or to provide services or information requested by you. Any such request must be made in writing and sent to the President of the Eradicate Hate Global Summit.

Aggregated Information.

We may collect statistical information about users of our website, such as the sites or pages that each visited, and their internet protocol addresses. We may also ask for, collect, and preserve information about our users' experiences and feedback concerning our website or other aspects of our operations. We may aggregate, share, and report that statistical information for business purposes; however, the statistical information will not disclose any individual's personal information. We will not share any personal information identified as a result of your use of our website without your prior approval. Nor will we use cookies without your permission.

Security.

We use commercially reasonable efforts to meet industry standards to safeguard the confidentiality of your personal information. Unfortunately, it is impossible to guarantee the security of data transmission over the Internet or any wireless network. Therefore, though we take commercially reasonable measures to protect your personal information, we cannot ensure the security of any personal information you transmit to us or from online services, and you do so at your own risk.

Limitation of Liability.

Each person assumes full responsibility and all risks arising from use of our website. All information and other content published on our website ("Content") is presented "AS IS" and may include factual inaccuracies or typographical errors. PRIVACY POLICY FOR EHGS BOARD AND OTHERS ASSOCIATED WITH EHGS

Board and Board committee members, officers, and volunteers. Unless required by law or for our financial records, we will not collect, preserve, or share personal information without your prior approval. We may collect, preserve, and share publicly available information concerning you, including photos or images of you, for our business purposes. (Please note that additional policies may also govern the use of such photos or images.)

Although we may post on our website or otherwise disseminate publicly available information concerning our Board and Board committee members, officers, and volunteers, we do not intend to post or disseminate any of their personal information.
